



Before there was regulation . . .

Activism – several standards groups eventually merged efforts into three key

groups

- GS1 US Healthcare
- Formation of Healthcare Transformation Group (HTG)
 - Geisinger Health, Intermountain Healthcare, Kaiser Permanente, Mayo Clinic, Mercy Health and 2018 add FMOLS
 - Working Calls & Summits to collaborate with Manufacturers, Solution providers – ERPs, EMRs. Advocacy groups, FDA, etc.
 - Education (internal & external)
 - labeling types, placement
 - Data exchange (GDSN)
 - Technology prep, scanners, etc.
- ARHMM Learning UDI Communities (LUC)

UDI REGULATION – 2013!!!

Opportunity

Regulation = low water mark USE of UDI
P2P "perfect order"
Operational Efficiencies
Patient Safety
Comparative analysis, etc.

Early Adoption learnings - "Opportunities"

- Disconnect between meeting the regulation requirements and operational down stream effect
 - Varied interpretation of rules "fit, form, function" by manufacture
 - Same item 12 variations due to plastics mfg change different GTINs
 - Lot vs GTIN change
- Change transparency/timing
- Variation in labeling stacked, concatenated, 2D, multiple non UDI barcodes
- Technology Solution provider gaps
- Slow provider adoption

UDI in use: Where we are today

- Supply Chain operations:
 - 96,026 UPNs(GTIN, HIBC, NDC) 79% of total item master (89% class II/III)
 - Data Exchange
 - GDSN
 - GUDID
 - GPO



• Receipt, putaway, delivery, item maintenance, kanban/ inventory relief, cycle counts, walkin, picking

Example: 80% error reduction in Receiving
