
Through the Technical Regulations (Official Mexican Standards) it is sought:







- o Physical and digital infrastructure for **Conformity Assessment**.
- Promote scientific, legal and industrial Metrology, as well as the creation of Designated Metrology Institutes.

Protects Legitimate Objectives of Public Interest (OLIP).

- The system protects the fundamental rights entitled in the Constitution and in international treaties.
- ✓ It establishes adequate measures for the protection of Health, Safety, Environment, Education, Right to Information, Food, among others.
- ✓ Addresses the causes of the problems identified by the Standardization Authorities that affect or put at risk the OLIP.
- Each Unit of the Federal Public Administration has an area of competence for its protection.





Regulatory Policy Cycle








Standardization Process





How does it work?

- Progressive and successive stages.
- ✓ Dialectical scheme.
- NOMs evolve over time along with the process of regulatory improvement
- The IASB determines the coordination mechanism between the different Standardizing Authorities when their competences affect.



The Standardization Authority publishes the project in the DOF for **Public Consultation** for 60 calendar days.


