It promotes an adequate management and implementation of the National Policy for Quality and the development of the Culture of Quality.


It investigates and identifies the demand and opportunities for the development of quality infrastructure, identifies gaps in quality and the development of intervention strategies.



PTS 329.200: 2020 MEDICAL MATERIALS Surgical masks. Requirements and test methods



It specifies the manufacturing, design, performance requirements, and test methods of surgical masks intended to limit the transmission of infectious agents from medical personnel to patients during surgical procedures and other medical settings with similar requirements.

Surgical masks type I are used for patients to reduce the risk of spreading infections, particularly in epidemic or pandemic situations.
