### Electronic Export Certificate Issuance



- Export Certificates for medical devices:
  - Not required by FDA
    - If legally marketed in the U.S.
  - Often required by foreign countries to allow importation.
  - Currently printed on security paper

## Electronic Issuance of Export Certificate



#### Old process

- Starting January 2, 2024, Exports Certificates and documents will no longer be:
  - Printed on security paper
  - Mailed

#### Unchanged process

 Still requested in CDRH Export Certificate Application and Tracking System (CECATS)

#### New Process

- If granted after review by FDA:
  - Requester receives an email with instructions
  - One time access to print or save a PDF within 45 days



## Electronic Export Certificate Issuance Communication

- July 10, 2023
  - 6 months prior to official launch
  - Officially announced transition to electronic certificates
  - Posted on FDA.Gov
    - Under Letters to Industry (<u>Electronic Export Documents Letter to Industry | FDA</u>)

In December 2023, the FDA will begin transitioning from paper export documents for medical devices to electronic export documents. For requests received on or before December 15, 2023, we will continue to issue paper certificates. For requests received on or after December 16, 2023, the FDA intends to issue paper certificates only if our review is completed prior to January 2, 2024. All certificates request reviews completed by the FDA after January 2 will be issued electronically. Export documents for human medical device products that CDRH regulates will be issued to requestors electronically as downloadable PDFs through the CDRH Export Certification Application and Tracking System (CECATS). Certificates may be validated by foreign governments and others using the FURLS Export Certificate Validator (FECV) database for the time period they are in effect. The FECV will be accessed using the URL address or QR code displayed at the bottom of each certificate. The change from paper to PDF export documents will improve efficiency in issuing export documents, reduce the amount of time it takes for a manufacturer to receive export certificates or Export Permit Letters, and decrease environmental burden, Read Electronic Export Documents - Letter to Industry,

An Agency may not conduct or sponsor, and a person is not required to respond to a collection of information unless it displays a currently valid OMB control number.

Please Note: The system will automatically time out if there is no activity for 30 minutes and you will need to re-do your work from the beginning.

## **Electronic Certificate Validation**

- FURLS Export Certificate Validator (FECV):
  - Allows direct validation from FDA databases
  - Accessible:
    - Within seconds
    - Via URL web address; or
    - Quick Response (QR) code
    - No account or software download needed
  - Displays the entire content of the certificate
    - secure
